

# **MANOR COURT DAY CENTRE**

## **Are you thinking about attending Manor Court Day Centre?**

If so, you may find the information in this brochure helpful to making your decision.

### **What is Manor Court Day Centre?**

Manor Court Day Centre provides Day Care services to older persons in accordance with the contractual arrangements in place between the Southern Health and Social Care Trust and Radius Housing Association.

Manor Court Day Centre provides day care in agreement with the Service User, their family and the health and social care

professionals who may be involved in assisting decisions on suitability of day care in meeting individual needs.

A key aim of day care is to support each individual living at home, their family/carer to continue to live a fulfilled and independent lifestyle.

Manor Court Day Centre will develop a person centered care and support plan to meet each service user's individual needs. This care and support plan will be agreed with the service user and family/carer following admission and will be reviewed and evaluated as and when required, to ensure the service we provide will continue to meet your actual needs and aspirations.

Manor Court Day Care welcomes the involvement of each Service User, their family, Next-of-kin, and health professionals in creating a care plan that will best meet each Service User's needs.

## **DAY CARE SERVICES CAN PROVIDE:**

Getting involved in meaningful activities, for example:-

- Reminiscence
- Sing-a-long
- Word, Board and Floor Games
- Skittles
- Arts and crafts
- Provision of meals and snacks catered to each individual service user's nutritional requirements, likes and dislikes

This list is not exhaustive.

## **OTHER SERVICES PROVIDED:**

- Helping you to feel safe and secure
- Personal manicures / hair styling

- In-house entertainment; storytelling, school choir visits, playing bowls / darts
- Coffee mornings, engaging with the community

Manor Court Day Care is registered with The Regulation and Quality Improvement Authority to provide day care services to older persons.

Manor Court Day Care is a locked door environment. Access to and from the scheme is managed through a finger point recognition door access system.

Manor Court Day Care has availability for private paying service users to attend the day centre outside of the allocated days from the SHSCT. There is limited availability per day and there is a cost of £26.50 per day, which includes all meals and refreshments.

The Scheme Co-ordinator and the Team at Manor Court Day Centre hope that this brochure will provide you with enough information to assist you and your family in making the right choice for your future needs.

## **IT IS YOUR CHOICE!**

### **HOW DO YOU APPLY?**

Applications for Manor Court Day Care can be obtained from your Social Worker, or from Radius House. Alternatively, a referral can be made to the Scheme Co-ordinator.

The Scheme Co-ordinator will undertake an assessment of need on receipt of referral or application. This is to ensure that Manor Court Day Care can meet your needs and that you are confident and content that Manor Court Day Centre is right for you.
